#### **Penalty for Wrong Answers**

There will be penalty for wrong answers marked in the Objective Tests. For each question for which a wrong answer has been given by the candidate one fourth or 0.25 of the marks assigned to that question will be deducted as penalty to arrive at corrected score. If a question is left blank, i.e. no answer is marked by the candidate, there will be no penalty for that question.

#### **Shortlisting**

Candidates will be shortlisted based on marks in online exam. A kind of certificate will be issued to the selected candidates for future reference and for future use. #### **Final Induction:**
